
Neillsville Furniture Company 1891-1910

In 1890, a group of local businessmen organized the Neillsville Furniture Company. The capital stock of the company (\$64,000) was owned entirely, by Clark County residents. The manufacturing plant was constructed in an "L shape", measured 136' x 128' x 64', was 4 stories tall and had over 51,000 sq ft of floor space. The building had an outside elevator, but no inside stairways!

Production began in 1891 when their first order for furniture came from London, England. Sales orders for the company's furniture line was so strong, that the owners ran into financial trouble. The business needed more working capital than stockholders had anticipated, and, in order to save the business, it was sold to a group of Baltimore Maryland businessmen. The name of the company was then changed to the **Wisconsin Furniture Manufacturing Company.**

The factory provided good employment for hundreds of area residents. Railcars of furniture were shipped to the east coast for sale to anxious buyers.

Unfortunately, in the early morning hours of June 28, 1910, a fire was discovered. Within 2 hours...the entire building was lost, leaving hundreds unemployed. A valiant effort, by local citizens, was made to raise money to rebuild, but in the end they fell short.

Clark County's 1st Jail was built in 1866 by Hewett Woods & Co. This is a picture of the 1st jail after it was no longer in use. Cost \$1300

While Clark County had been officially organized in 1853 by the State of Wisconsin, it did not have a Jail (building) until 1866. The new Jail was to be completed by September, 1866, in time for the beginning of the September term of court. It was about 20' x 24' one story high and built with iron, oak planks and spikes. It had one large room and a few small cells

In 1881, a 2 story Sheriff's residence was built that adjoined to the new 2nd Jail immediately behind it. Total cost for this construction (including cells) was about \$8000. While the structure was an improvement over the 1st Jail, it was not modern or sanitary. Several prisoners managed to escape, and in 1896 the County Board appropriated

Clark County's 3rd Jail and Sheriff's Residence—Built in 1897 at a cost of about \$15,000.

\$15,000 to construct the 3rd Clark County Jail and Sheriff's residence. Completed in 1897, this structure would serve as the Sheriff's home until 1974, and as the County Jail until 1978. Thanks to the efforts of the Clark County Historical Society, the structure was saved from demolition and is now the home of the Jail Museum.

Civil War Sesquicentennial (1861 to 1865)Begins this Year

In 1861, the Civil War (or the Great Rebellion) began. Clark County WI, had a total population of about 800 citizens, and yet sent more than it's share of recruits—nearly one full company. Many of those first recruits did not return...and those that did, as in all wars, bore the mark of battle the rest of their lives.

2011 marks the 150th Anniversary of the beginning of the Civil War. Over the next 5 years, we will revisit this chapter of America's history and the part Clark County and it's citizens played in it.
